**\$43,660,000 GENERAL OBLIGATION BONDS
SCHOOL DISTRICT OF BEAUFORT COUNTY, SOUTH CAROLINA**

Shall the Board of Education of the School District of Beaufort County, South Carolina (the "School District") be empowered to issue, at one time or from time to time, general obligation bonds of the School District, in a principal amount of not exceeding \$43,660,000, the proceeds of which shall be used to finance the cost of constructing, improving, equipping, expanding, renovating and repairing school facilities within the School District, as follows:

New Elementary School in the Bluffton Area in an amount not to exceed \$16,260,000;
New Middle School in the Bluffton Area in an amount not to exceed \$23,500,000;
Land Acquisition for North Area High School in an amount not to exceed \$1,500,000;
and Completion of North Area High School in an amount not to exceed \$2,400,000.
