Shall the Board of Education of the School District of Beaufort County, South Carolina (the "School District") be empowered to issue, at one time or from time to time, general obligation bonds of the School District, in a principal amount of not exceeding \$162,735,000, the proceeds of which shall be used to finance the costs (including architectural, engineering, legal and related fees) of acquiring, constructing, improving, equipping, expanding, renovating and repairing school facilities within the School District, as follows:

EXPLANATION:
Such question is being submitted pursuant to Article X, Section 15 of the Constitution of the State of South Carolina, 1895, as amended; Section 11-27-50 of the Code of Laws of South Carolina 1976; Title 59, Chapter 71, Article 1, Code of Laws of the South Carolina, 1976, as amended; and a resolution of the Board of Education of the School District adopted January 15, 2008. If a majority of the qualified electors of the School District voting in the Referendum approve the issuance of not exceeding \$162,735,000 General Obligation Bonds (the "Bonds"), the Bonds may be issued by the School District either as a single issue or from time to time as several separate issues. The Bonds (exclusive of refunding bonds) shall be issued within five (5) years of the date of the Referendum. The proceeds of the Bonds will be used to defray the costs (including architectural, engineering, legal and related fees) of constructing, improving, equipping, expanding, renovating and repairing school facilities within the School District.
